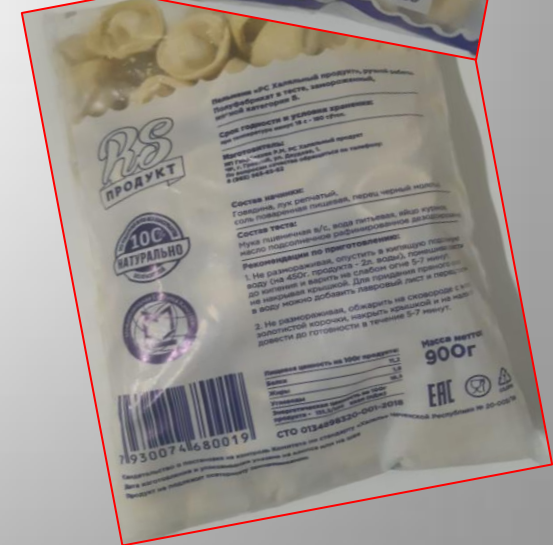
The uniqueness of the products lies in the fact that the specified products
